Animal Check-in time

Your animal is required to be checked-in at least 40 minutes prior to departure. To achieve this, you should aim to be at the airport at least 50 minutes before the scheduled departure time.

Our aim is for your animals' check-in to be friendly, easy and efficient. To assist you this note provides information on check-in times, identification requirements and which sections of the form need to be completed.



ANIMAL DROP OFF AND CAGE REQUIREMENTS

You must arrange for your animal to be dropped off and picked up at the airport. The animal must be kept inside its cage at all times while on the airport grounds. Originair requires the person checking-in the animal to remain in the airport terminal until the flight has departed. Originair will make every effort to ensure the safe travel of your animal but please be aware there will be exposure to the airport environment that includes loud noises, changing temperature and weather conditions. It therefore helps if your animal has been crate trained prior to the flight, this will ensure your animals journey is less stressful. The cage must comply with the current IATA Live Animal Regulations https://www.iata.org/whatwedo/cargo/live-animals/Pages/index.aspx. Due to the access and size of our aircraft hold please ensure the cage is no wider than 430mm. Your animal must be able to stand up comfortably and turn around with no restrictions.
